To All Members of the DCRB:

RE: WORKERS COMPENSATION DATA PRO

The DCRB is pleased to announce the release of a new product, Workers Compensation Data Pro (WC Data Pro). WC Data Pro is a powerful and useful web application only available to DCRB member carriers that provides access to their aggregated premium and loss data. Carrier members can now benchmark their data against statewide data by various policy and claim characteristics. WC Data Pro also allows carriers to extract their data for further analysis.

WC Data Pro will be released in multiple phases over the next year. Phase 1, released today, focuses on premium and loss unit statistical information. Phases 2 and 3 will provide access to additional calculations and groupings for premium and loss information, as well as pricing information. More information will follow in the months ahead.

WC Data Pro is only available to carrier group users. The application has been made available to each DCRB member's Carrier Group Administrator (CGA). As is the case with most DCRB products, carrier user access is managed directly through each CGA. Please contact your CGA to request individual access and permissions as required.

The DCRB will host two online training sessions for those carrier users who are interested in learning more about WC Data Pro. The training will be offered on February 7, 2017 and on February 16, 2017. If you are interested in attending either of these sessions please complete the attached form. Additionally, the DCRB will conduct training sessions on an individual carrier basis on request.
